



# Fall 2019 Entry Form

**Entry Form & Fee Deadline:** Oct 1, 2019  
**Entry Fee:** \$50/head

- Entry form and fees must be received by Oct 1st to reserve pen space for your animals.
- Copies of registration papers and completed field sheet must be presented at time of delivery, as well as documentation of required health testing, as listed below.
- Animals will not be unloaded at the GDC without the required health documentation!
- Animals will be delivered between the hours of 8:00 a.m. and 5:00 p.m. on the delivery dates below unless a special appointment has been made with GDC staff.

## Eligible Birth Dates to Enter

Fall 2018 – March 31, 2019

(Early fall 2018 calves will be scanned according to Breeds age requirements)

## Fall 2019 Schedule

Fall 2018 – March 2019 born calves	
Nov 04 – Nov 08 2019	Receive cattle
Nov 29 -2019	Start Growsafe
Feb 07 - 2020	End Growsafe
March 20 - 2020	End test

## Health Requirements

- **Documentation required to be unloaded at facility!**
- Proven **Tuberculosis** Negative within 60 days of arrival. TB testing can be done at local vet clinic in Navasota, TX
- Bulls and heifers are proven **Brucellosis CF** Negative within 30 days of arrival
- All entries proven **BVD PI** negative
- Veterinarian or vet supplier approved and documented vaccinations for: **Pasteurella, Manniheimia, Haemophilus Somnus, 8 way Clostridium, IBR, BVDV, PI3, BRSV**
- Must be weaned 45 days prior to delivery
- Two rounds of vaccinations with at least one of those rounds using a modified live vaccine

## Genetic Development Center Features

- Two regularly-scheduled tests/year; Summer & Fall
- 640 head one-time capacity; capable of 1280 head/year
- All pens are 200' x 60' with 32 head/pen
- 375 ft<sup>2</sup>/head with plenty of shade provided
- 70-day gain test with 21 day diet adaptation period
- Cattle processed into contemporary groups based on breed, weight and age
- Carcass ultrasound, Breeding Soundness Exam, and Yearling Measurements included in the cost of test
- On staff veterinarian and a consulting nutritionist
- Custom designed rations at privately owned mill
- Bulls with horns 6" and less can be efficiency tested

## Costs

1. The total all-inclusive fee for the full 133 days is **\$870** per bull and **\$840** per heifer. This includes Feed costs, GrowSafe feed efficiency data, carcass ultrasound, yearling measurements, Breeding soundness exams, progress reports, entry vaccinations, tagging, weighing, yardage, etc.
2. Producer price who enters at least 32 head will be **\$820** per bull and **\$790** per heifer. Same installments as below will be applied.
3. A non-refundable entry fee of \$50 per head is **due by Oct 1<sup>st</sup> 2019** with entry form. No charges are due upon arrival. Four installments of **\$205** per bull and **\$197.50** per heifer will be billed at the end of each month
4. Veterinary expenses will be charged as occurring.

## Feed Ration

A total mixed ration (TMR) consisting of steam-flaked corn, chopped hay, roughage pellet, corn silage, protein premix and molasses targeting 3.5 lb./day gain for bulls and 2.5 lb./day gain for heifers will be fed ad-libitum according to our on-staff nutritionist and Ecofeed guidelines
